MUSD begins in-person learning September 14

It's been over five months since students have set foot on campus, as an estimated 40% student population returns to in-person learning this week for grades K-5.

Maricopa Unified School District Governing Board voted to allow in-person learning after lengthy consideration and review of the improved Arizona Department of Health Services Benchmark Data released on September 3, as noted in the September 4, Superintendent's Snapshot.

Middle and High School Students will return to in-person learning on September 21, as MUSD staggers the class schedules.

Despite the many challenges amid COVID-19, students, parents, and school faculty seem very optimistic about the return to brick and mortar setting, as the hustle and bustle of early morning routines everyone knows all too well resumes.

On-site learning labs were opened for free full-day learning options as

of September 8. Students wanting to attend the free on-site labs will need to register, availability is limited. Contact Traci Manoguerra at 520-568-6150, ext. 2359, for registration information.

The Summer Feeding Program also received a waiver from the USDA, which will allow the extension of free meal service for all children 18 years and younger. MUSD will provide the free meals through December 31. Grab-and-Go meals may be picked up at any MUSD school site. Students attending

in-person learning will receive their meals during their school day.

For those families who are continuing with online/distance learning, MUSD encourages families to visit BLOCKSI Parent Dashboard website for helpful instruction.

As MUSD welcomes back students, they will continue to follow enhanced safety protocols outlined in the MUSD Mitigation Plan to prioritize everyone's safety and monitor data on the ADHS website.

SUV rolls over on Hwy 347

On the morning of September 16, at approximately 9:06 AM, Ak-Chin Fire Department was dispatched to the intersection of Farrell Rd. and Highway 347 for a reported motor vehicle collision with injuries.

The vehicle was reportedly traveling southbound on Highway 347 when it possibly struck the median curb resulting in the SUV rolling over onto its roof.

Ak-Chin Fire units arrived within minutes of dispatch, finding an overturned SUV with five occupants, three of which required manual and mechanical

extrication.

Ak-Chin Fire immediately requested additional assistance from Maricopa Fire Department, American Medical Response, Air-Evac, and Gila River EMS.

The three occupants were extricated after Ak-Chin and Maricopa Fire crews stabilized the vehicle and were treated on the scene for their injuries.

Ambulances from Ak-Chin Fire and American Medical Response transported the three occupants to Chandler Regional Medical Center as Level 1 Trauma victims.

Additional crews from Gila River EMS assisted in evaluating the two remaining occupants and were released from the scene.

Crews from Ak-Chin and Maricopa Fire Departments assisted Law Enforcement and the Wrecker Operator with minor roadway clean up.

The cause of the incident is being investigated by Arizona Department of Public Safety and is still pending.

September is National Suicide Prevention Month

Suicide is a heavy topic, its melancholic, stressful and full of unmeasurable hurt. It's a subject many stay clear of, something that will never be easy to talk about, but it will always be a subject that needs to be discussed.

One's mental health is also a touchy subject; a lot of people can feel embarrassed and at a loss of self by the fact they have these barriers in their life. They need to know they are not alone. One in four people around the world will be affected by disorders sometime during their lives, it's not as uncommon as many think it is. As a community we've been through a variety of unforgettable events and we can help prevent suicides from happening.

Knowing the signs and characteristics of someone considering suicide or attempt is a major key in helping those who see no other way out. These warning signs can vary but knowing someone can help someone in the future; sense of hopelessness, impulsive

and or aggressive tendencies, extreme mood swings, having a history of trauma or abuse, mental disorders/mood disorders i.e.: schizophrenia, substance and alcohol disorders, lack of support, sense of isolation, lack of healthcare, loss of relationships and so on.

These factors can lead to undoable deeds, the stigma for asking for help can also lead many to their death beds. One should not feel shame about asking for help. No one should ever have to suffer alone. Suicide effects millions of people every day, CDC's Data and Statistics Fatal Injury Report recorded 48,344 deaths caused by suicide in 2018 and an estimated 1.4 million suicide attempts in the US.

In Arizona the number of deaths by suicide are 1,438; it's the 8th leading cause of death in the state, on average a person dies by suicide every six hours in the state. Numbers, facts, statistics, can show and tell you a lot about the country and state, but

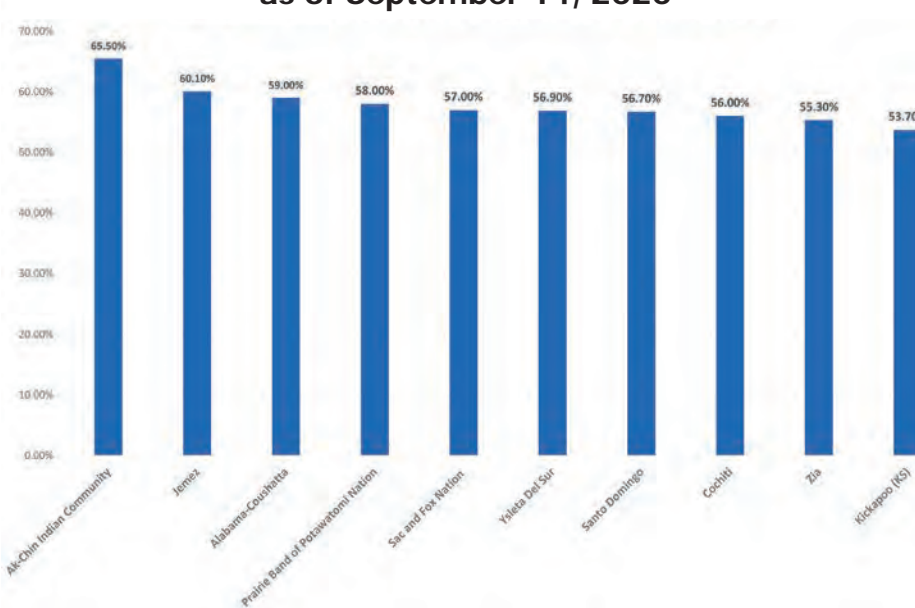
what about stats in our Native communities?

Recorded by the CDC in 2017, From 1999 to 2017, American Indians/ Alaska Natives males and females have had the largest increase in suicide rates than any other ethnicities in the United States. Population Reference Bureau recorded that American Indian and Alaska Native teenage girls and boys also had increased at an alarming rate.

What can be done to prevent tragedies from happening in our community? Knowing warning signs, but most importantly talking about it. Showing love and support to others who may be having a hard time could help them in the long run. We never know what others are going through, but we can make sure they don't feel abandoned.

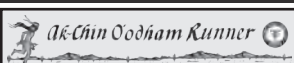

Dear fellow Mali:na walkers

Many of you have
been asking us about
this year's walk. It
was difficult to give
an answer due to the
coronavirus that has
taken over the world.

My condolences to you
who have lost someone
to this virus.

It saddens me to send
this out to you all at
this late date. I know
that this pilgrimage is
so important to you and
me. It is so much a part
of us, it is where we
get our strength to get
through times like this.
I have been going back
and forth as to what to
do for the pilgrimage
so I feel that I have to
address it;

In talking to other
walkers from our group,
most of us feel it would
be better if we not
walk this year. We took
in the consideration
of underlying health
issues that some of
the walkers are already
dealing with in their
personal lives and don't
want to put any more
stress on each other.

We thought about the
extra precautions each
person has to consider,
getting tested at least
twice before going,
taking extra sanitizer
(hands and wipes)
and masks, most of all
walking long distances
with a mask, and resting
and sleeping in close
areas.

Mali:na is still
welcoming visitors for
the Feast of St. Francis
(October 4th). My
understanding is that
the chapel will be open
for people to view St.
Francis, he will however
be laid in a case, you
are allowed to go up
and see him but will not
be allowed to touch the
case and only 8 people
will be allowed in at a
time.

Although the pilgrimage
is not about anything
other than yourself and
building your strength
and faith with St.
Francis, there will also
be no street vendors, no
music, no carnival, and
the O'dham office will
also not be in operation
this year. The shops in



the plaza will be open.

I do encourage you to
pray with your families,
maybe set up an altar
outside your home
and do a rosary every
evening or do a personal
walk every morning
from September 28 to
October 3 (the days
we would be walking)
or walk to your church
and do a rosary sitting
outside the church,
and doing your final
rosary on the Feast Day.
Just some suggestions.
Maybe even wake up
at 3:00am and start
walking at 4:00am.

Thank you for your time
and understanding.
God bless you all, you
are all in my heart and
prayers and I hope to
see you soon.

REQUEST FOR PROPOSALS

Ak-Chin Indian Community

Sealant Program for Farrell Road and Peters & Nall Road

The Ak-Chin Indian Community
("Community") is seeking road maintenance
services to conduct road maintenance of coat
sealant, replacing striping, and traffic control.
The Maintenance Area totals approximately
937,325 square feet or 5.35 +/- miles of
two major road of the Community, Farrell
Road and Peters & Nall Road (see attached
map). The purpose and intent of this Project
is to preserve existing asphalt surfaces by
application coat sealant that is to include any
and all labor, materials, tools, equipment,
skills and services necessary or required to
produce the finished results described herein.

I. Background

The Maintenance Area consists of two main
roads severing the Ak-Chin Indian Community,
Farrell Road and Peters & Nall Road. Both
roads connects to SR347, two lane roads and
has a bridge crossing over Smith Wash.

Farrell Road surface is showing its age. Farrell
Road services a number of Government
Facilities; such as, Public Safety Facilities,
Clinic, Elder Center, etc., Vekol Market, Antone
Park, and Village Residents. The entire road
is a no passing zone. Peters & Nall Road work
area is approximately 2.38 +/- miles and 394,238
square feet of surface. Farrell Road work
segment is from SR347 to Santos Road.

Peters & Nall Road was resurfaced in 2016.
Peters & Nall Road services the Tribal
Headquarters, Ak-Chin Farms Enterprise,
and residents. Peters & Nall Road partly
shares centerline jurisdiction with the City
of Maricopa. The road goes in and out of no
passing zone. Peters & Nall Road work area
is approximately 2.97 +/- miles and 543,087
square feet of surface. Peters & Nall Road
work segment is from SR347 to White and
Parker Road.

II. Project Description – Scope of Work

The project deliverables are as follows:

1. Furnish all labor, equipment and material
to apply coat sealant to Farrell and Peters
& Nall Roads.
2. All machinery, equipment and materials
of the Contractor shall be situated
so as not to endanger the public, or
inconvenience public travel on open traffic
lanes. Contractor's equipment and work
operation shall not cause unnecessary
annoyance to the public.
3. Farrell Road will receive Slurry Coat
Sealant Application
4. Peters and Nall Road will receive Fog Coat
Sealant Application.
5. Traffic Control Plans for both roads on
detouring and traffic control
6. Obtain encroachment permit from ADOT
with traffic control plan for SR347 for each
road intersections of Farrell Road/SR347
and SR347/ Peters & Nall Road.
7. Obtain encroachment permit from the
City of Maricopa with traffic control Plans
for Peters and Nall Road
8. Clean existing asphalt surface to remove
dust, dirt, and debris prior to application
of the coat sealant.
9. The routing and cleaning must be
conducted on the same day. The routing
and cleaning prior to the day of sealing
shall not be permitted. The sealing shall
not be applied unless the ambient air
temperature is 45 °F and rising.
10. Mask Cover or protect manholes,
monument pins, etc., that lay within the
road.
11. The Contractor shall designate one
(1) person on each work crew to be
responsible to the Community for traffic
control set-ups, marking and measuring

work, acquisition of construction
materials, scheduling, etc. The said
designated person shall be familiar with
the work, may be a member of the work
crew, shall have authority to act for the
Contractor and is able to receive and
execute orders.

12. Contractor shall be responsible for traffic
control during the project. Road closures
will not be permitted. All work within the
roadway shall be conducted under traffic.
Two-way traffic shall be maintained at all
times. All work zones shall be properly
signed and set-up in accordance with the
Manual of Uniform Traffic Control Devices
(MUTCD), latest edition.
13. Contractor must agree to perform the work
safely, ensuring that all proper protective
gear, eyewear, etc. is worn while work is
completed. Appropriate reflective clothing
is required. The Community's TOSHA
safety requirements must be followed at
all times while performing work.
14. All permanent longitudinal pavement
striping (centerline, lane lines, etc.)
must use thermoplastic AASHTO M 249.
Reflective glass beads must be applied
accordance with AASHTO M 247.
15. All permanent lateral pavement striping
(stop bars, crosswalk lines) must use
thermoplastic AASHTO M 249, Reflective
glass beads must be applied accordance
with AASHTO M 247.
16. All pavement arrows, legends, crosswalks,
etc., must use thermoplastic AASHTO M
249.
17. All raised pavement reflectors must be
installed with CRAFCO pavement reflector
adhesive or equivalent.
18. Prior to any work beginning on the
project, the Contractor shall submit to
the Sanitation/Public Works Director a
manufacturer's certificate stating that the
saltant material complies with the above
requirements.

The Community will make available GIS shape
files, aerial photography, and other available
information to the selected consultant team.

Nominations are sought for Ak-Chin members
who are interested in being a candidate to serve as
Chairman and Vice Chairman for a four (4) year term
commencing in January 2021.

AFFIDAVIT OF QUALIFICATIONS

All candidates will be required to sign a notarized
**Affidavit of Qualifications for Community Council
Member**. Affidavits will be available at the Tribal
Headquarters through Marilyn Thompson beginning
**Friday, August 21, 2020 through Monday, September
21, 2020, between the hours of 8:00 AM and 5:00
PM**. Affidavits must be completed and turned in **no
later than 5:00 PM on Monday, September 21, 2020**.

ALL CANDIDATES MUST MEET THE FOLLOWING QUALIFICATIONS:

1. Is currently an enrolled member of the Ak-Chin
Indian Community and has been an enrolled
member of the Ak-Chin Indian Community for at
least one (1) year immediately preceding the date
of the election, where such membership is not
based on adoption under Section 2 (b) of Article II
of this Constitution, AND
2. Is at least twenty-five (25) years of age, AND
3. Has been residing on the Ak-Chin Indian Reservation
or on land owned in fee by the Ak-Chin Indian
Community, for at least one (1) year immediately
preceding the date of the election, AND
4. Has never been convicted of a felony or of a
misdemeanor involving dishonesty in any tribal,
state or Federal court or of an offense which would
constitute a felony or a misdemeanor involving
dishonesty under the laws of Arizona.

ABSENTEE BALLOTS

Any eligible voter who wishes to vote early or who
expects to be absent from the Reservation on any
election day, or who expects to be physically unable
to go to the voting place on such day, may request
an absentee ballot by either appearing in person
as instructed below or by sending a letter to the

Nall Road, Maricopa, Arizona 85138. **Absentee Ballots
may be requested in-person from Marilyn Thompson


Child Passenger Safety Week


